Extensive Student Feedback System

2. The Context

SNSC believes that, quality higher education is possible only where there is greater and enhanced teacher-learner interaction. Also, continuous student feedback enables active student participation in the implementation of quality enhancement strategies.

3. Objectives of the Practice

- To provide feedback to the teaching faculty members.
- To enhance the quality of teaching across the college
- To build an atmosphere wherein, the teachers and students interact and engage in a system of mutual learning.

4. The Practice

- Students can write their feedback/grievances online and offline.
- A systematic Student Feedback / Survey are conducted by the Internal Quality Assessment Cell (IQAC) once every year.
- The students are asked to rate the instructor of their concerned subjects on various vital parameters.
- The students' responses are automatically analysed on a point scale by the system and it is monitored by a mechanism under the control of Principal.

5. Advantages
